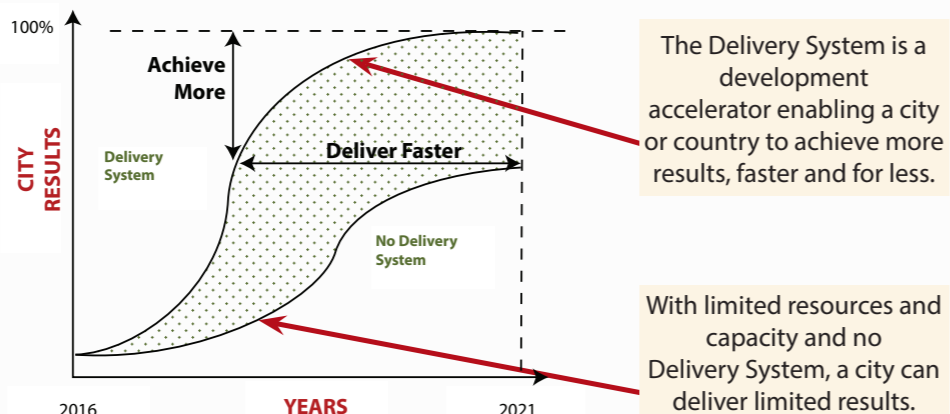
THE METHOD

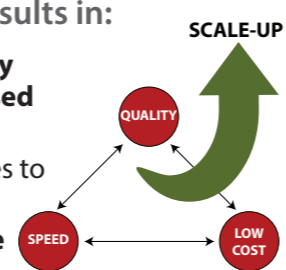

2. Is the plan based on what works?

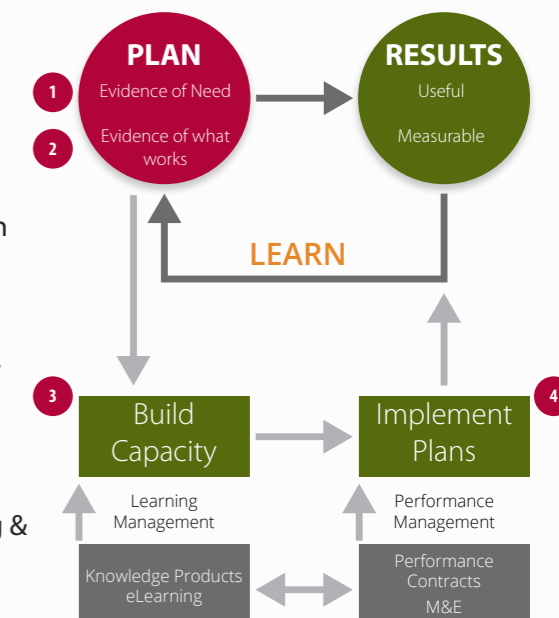
Yes, the plan uses proven good practice solutions gathered through the platform.

4. And will the plan be implemented?

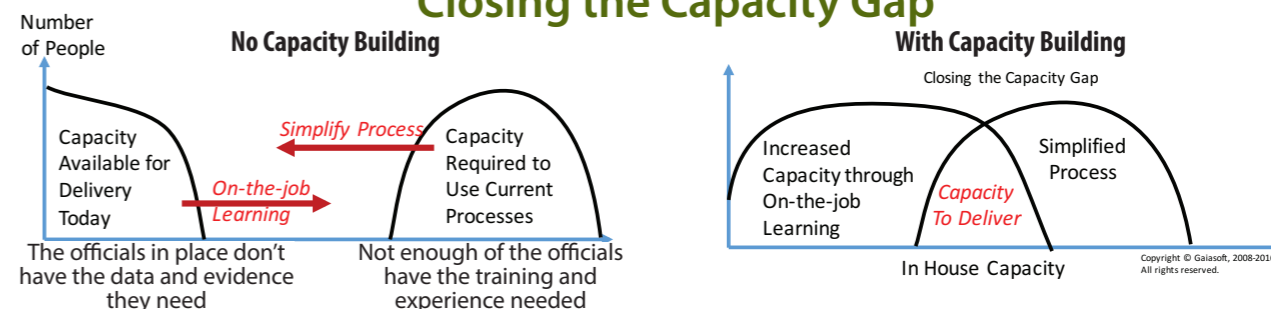
The plan is implemented... using performance management, aligned performance contracts of officials and real-time Monitoring & Evaluation of results.
